Trade Means Growth for Nevada

International trade—exports and imports of goods and services—supports 420,000 jobs in Nevada, or about 2 in 9 total jobs in the state.

Key facts about trade and jobs:

- The share of Nevada jobs supported by trade has nearly doubled since the early 1990s.
- · Jobs in export-intensive industries offer compensation that averages about 16 percent higher than other jobs.
- · Imports let American families stretch their budgets and help U.S. manufacturers keep costs down and competitiveness up.
- Nearly 3,600 Nevada companies exported in 2022. Nationally, 97% of trading firms are small-and medium sized enterprises.
- · Since 2008, companies that import or export goods have accounted for 3 out of 5 new American jobs.

Nevada companies exported \$18 billion in goods and services in 2023 to more than 190 markets around the world.



America's FTA partners account for just 6% of the world's population but purchased 38% of Nevada's goods exports in 2023.

Nevada's goods exports to Taiwan were \$216 million in 2023, an increase of over 350% since 2014.

Canada was the top export market for services exports in 2023 at \$982 million.

Nevada's total goods and services exports increased by \$557 million (3.2%) between 2014 and 2023.

In 2023, Nevada exported \$9.5 billion in goods and \$8.3 billion in services.

Most services export growth has been driven by digital trade, which is allowing more Nevada companies to reach customers abroad more easily.

Nevada's top travel services exports in 2023 were personal travel (\$3.5 billion) and business travel (\$1.3 billion).

Nevada's top food and agricultural exports in 2023 were coffee (\$114 million) and powdered milk (\$54 million).

Nevada's exports of digitally tradable services reached \$2.3 billion in 2023.

Foreign-headquartered companies directly employ 60,800 Nevada workers.

Canadian-owned companies employ the most Nevada workers (10,600), followed by British-owned companies (10,200).

Each job at a foreign-owned company typically supports three other U.S. jobs indirectly.

In 2021, U.S. affiliates of foreign-owned companies employed 8 million Americans, exported \$412 billion in goods, and spent \$78 billion on R&D.
